Department Reports

Councilman DiDomenico presented the Police Department report for June with total calls for service, traffic accidents and enforcements, complaints, and investigations.

Councilwoman Hess presented the library report including new members and fees collected. Connections will be at the Lindenwold Library every Friday. These programs have been going well and a benefit for the community. Next one will be a craft on July 13. Summer reading has started and will end August 23. The next movie in the park is Cars III on July 20 and encourages everyone to come out.

Business Administrator asked the Borough Engineer to report on the Berlin Road Streetscape Program.

Councilman Jackson reported on the number of violations in Code Enforcement for last month. A business opened on Berlin Road without approval. Under Park and Recreations, a coach list is being submitted for the organizations. Lindenwold Baseball will be holding a tournament the end of July. Football starts July 23. Final registration for Cheerleading is July 16. The Homerun Derby was July 1 which was excellent but a tad hot. The Mayor added for Code Enforcement to keep up the good work and that it is making a difference in town. Councilman Jackson added that two additional Code Enforcement Officers are in the field.

Councilman Strippoli presented the Public Works Report for June regarding trash and recycling collections and property maintenance. For the Sewer Department, he presented the number of service calls, stoppages, and emergencies. The Mayor added that the number for recycling should be much higher. Information is available on the website on what to recycle instead of putting in the trash.

Councilwoman Sinon announced that the Municipal Alliance Summer Program has started. Lunch is provided as well as field trips. National Night Out is August 7. Plans are being finalized for the event. She invites everyone to come out for the event.

Engineer's Report was provided by Anthony Chadwell of Remington and Vernick. Approval was given on May 9 for Laurel Road Pedestrian Improvement project. A survey will be performed as soon as possible. A survey is scheduled for the Chews Landing Road Pedestrian Improvements Project. Grant applications will be submitted for additional grants including a bicycle path at the Lindenwold High School and park and for the traffic signal upgrade at Egg Harbor Road and Gibbsboro Road. A few items remain on the construction project of Laurel Road Pedestrian Improvements. Work is completed on the reconstruction of South Carlton Street. Approval has been received for the contractor to continue the Berlin Road Streetscape Phase 2 project.

Mayor Roach opened the meeting to the public. There being no one desiring the floor, the Mayor closed the meeting to the public.
