RESOLUTION 2018:193 Execution Of A Redeveloper's Agreement With AW Urban Renewal, LLC, Or Its Assigns, Relative To This Designation

WHEREAS, on August 9, 2017 by Ordinance No. 2017-15, the Borough Council of the Borough of Lindenwold adopted the Redevelopment Plan relative to the property known and designated as Block 243, Lots 7.01, 7.02 and 7.04, and all Qualifiers therein, of the Official Tax Maps of the Borough (hereinafter designated as the ("Real Property") commonly known as Arborwood Redevelopment Plan ("Redevelopment Plan"), for the Borough of Lindenwold ("Borough"); and

WHEREAS, in order to implement the Redevelopment Plan and carry out the redevelopment projects in the area designated by this Redevelopment Plan, the Mayor and Council of the Borough of Lindenwold has determined that it is necessary to designate a redeveloper for same, subject to certain conditions; and

WHEREAS, the Borough as determined to designate AW Urban Renewal, LLC, or its assigns, as the redeveloper for the purpose of carrying out the Redevelopment Plan as it relates to Block 243, Lots 7.01, 7.02 and 7.04, and all Qualifiers therein, on the Official Tax Map of the Borough of Lindenwold, subject to certain conditions; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Lindenwold that the Borough Council hereby designates AW Urban Renewal, LLC, or its assigns, as the Redeveloper for the purpose of carrying out the redevelopment project in the area designated by the Arborwood Redevelopment Plan as it relates to Block 243, Lots 7.01, 7.02 and 7.04, and all Qualifiers therein, on the Official Tax Map of the Borough of Lindenwold; and

IT IS FURTHER RESOLVED by the Mayor and Council of the Borough of Lindenwold that this redeveloper designation is subject to the following conditions: (1) dismissal with prejudice of the lawsuit entitled Pine Ridge Investments, LLC and Wakefield Holdings, LLC vs. Borough Council of the Borough of Lindenwold and the Joint Land Use Board of the Borough of Lindenwold, venued in the Superior Court of New Jersey, Law Division, Camden County under Docket No. L-2562-17; (2) presentation of sufficient documents evidencing, in the opinion of the Borough, the financial and economic capability of the redeveloper to undertake and complete a project of this size and magnitude; and (3) the execution the appropriate Redeveloper's Agreement with the Borough for the purpose of carrying out the redevelopment project in the area designated by the Arborwood Redevelopment Plan; and

IT IS FURTHER RESOLVED that Richard E. Roach, Jr., Mayor of the Borough of Lindenwold and Deborah C. Jackson, Borough Clerk of the Borough of Lindenwold, is hereby authorized to execute the appropriate Redeveloper's Agreement with AW Urban Renewal, LLC, or its assigns for the purpose of carrying out the redevelopment projects in the area designated by the Arborwood Redevelopment Plan as it relates to Block 243, Lots 7.01, 7.02 and 7.04, and all Qualifiers therein on the Official Tax Map of the Borough of Lindenwold, subject to the advise and consent of the Borough Council of the Borough of Lindenwold.

Department Reports

Councilman DiDomenico presented the Police Department Activity Report for July, 2018. He thanked the Police and Fire Department for last night's National Night Out.

Councilwoman Hess informed the residents that the Environmental Commission handed out free trees at last night's National Night Out. The Lindenwold Library is continuing its summer reading program. A craft is scheduled every Thursday. The concert and car show was just held. This event went well even with the rain with cars coming out. The rain stopped so everything went well. Our next movie is Coco on August 17. The Camden County Sheriff's office will hand out backpacks with school supplies. A magician is scheduled before the movie at 7:00. Our next concert is August 24 which is a Billy Joel Tribute Band at 8:00pm in the park. Lindenwold day is coming up quickly on September 22 from 11-7. There will be games, rides, food, and fireworks.

President Randolph-Sharpe remembered Mr. Norbert who really cared about this community. He will be missed. Business Administrator had nothing at this time.

Councilman Jackson presented the Code Enforcement report for July. Under Park and Recreations, he announced that Rutgers University is looking to use the Lindenwold field for 15 games starting in March. Someone came to the Park meeting who is interested in restarting the soccer program. There were approximately 300 participants in this program in the past.

Councilman Strippoli presented the Public Works report for July and the Sewer Department report for July. Councilwoman Sinon had no report.
