RESOLUTION 2021:77 Authorize Repaving of Linden Town Phase 2

WHEREAS, there is a need for the Borough of Lindenwold to have a review, preparation of specifications and construction oversight for the FY2021 NJDOT Trust Fund for Repaying of Linden Town Phase 2(M2020-240)in the Borough of Lindenwold; and

WHEREAS, under the Fair and Open process, the Borough of Lindenwold received and awarded an Engineering Services contract for the year 2021 to Remington and Vernick of which includes writing of specifications and contract administration in their scope of work, and

WHEREAS, Remington and Vernick submitted a cost proposal on December 21, 2020.

THEREFORE, BE IT RESOLVED by the Mayor and the Borough Council, County of Camden, State of New Jersey to authorize Remington & Vernick Engineers to prepare the review specifications for FY2021 NJDOT Trust Fund for Repaving of Linden Town Phase 2(M2020-240) with a cost for engineering and construction oversight to be funded by the grant with the estimated cost to the Borough for the amount awarded by the New Jersey Department of Transportation with a not to exceed estimated project total cost of \$402,771.00.

RESOLUTION 2021: 78 Authorizing the Award of Computer Services

WHEREAS, the Borough of Lindenwold has a need to acquire computer services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and,

WHEREAS, the Borough of Lindenwold has determined and certified in writing that the value of the acquisition will exceed \$17,500; and,

WHEREAS, the anticipated term of this contract is for the period of January 1, 2021 until December 31, 2021; and WHEREAS, Bellia Technologies has submitted a proposal indicating they will provide computer services for the not to exceed amount of \$40,000; and

WHEREAS, Bellia Technologies has completed and submitted a Business Entity Disclosure Certification which certifies that Bellia Technologies has not made any reportable contributions to a political or candidate committee in the Borough of Lindenwold in the previous one year, and that the contract will prohibit Bellia Technologies from making any reportable contributions through the term of the contract; and

NOW THEREFORE, BE IT RESOLVED that the Mayor and Borough Council of the Borough of Lindenwold authorizes the contract with Bellia Technologies as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file in the Borough Clerk's office; and

BE IT FURTHER RESOLVED that notice of this award will be advertised in the official newspaper.

Mayor Roach opened the meeting to Council.

Councilwoman Sinon informed the residents of a "pop-up" vaccination site scheduled for eligible Veterans on Saturday, January 30 in Runnemede. Pre-registration is required. Camden County has started their vaccination site at the Camden County College. Information is very positive regarding the operation of the site with the scheduling of the second vaccination before leaving. Also, the testing site at the Camden County Public Works is still being held on Saturday and Tuesday.

Mayor Roach stated his goals for 2021 is to make the town safer and try to protect residents due to the high numbers for the virus. The current number of cases is 1,593 with 18 deaths. Regarding the use of fields, currently they will remain closed similar to the schools. Once schools reopen, the matter will be discussed.

Mayor Roach opened the meeting to the Public.

Diane Veteri, resident, questioned who was in charge of Economic Development and how often do they meet? Mayor responded the Borough does not have this organization. Resident again asked the Mayor regarding his goals for underperforming schools, crime and taxes. Mayor responded that municipal taxes did go down. Crime has also been on the decline. He suggested the resident attend the School Board meetings as Council has no authority.

Taalib Henderson, resident, stated that school sports were open. The Mayor clarified the reopening of the schools themselves. The Mayor responded that Council opposed opening the fields. Council and resident continued to discuss this matter.

Trevor Shaw, resident, asked if Borough Hall was still closed. Mayor affirmed. Resident questioned the access to the ordinances. Mayor clarified that it was the first reading by title. Resident asked how often Park and Recreation met. Councilman Jackson responded prior to the virus, once a month. Resident and Councilman Jackson continued to discuss. Dan Brittin, resident, questioned the damage to his property by South Jersey Gas with the gas project. Mayor asked resident to send information.

Danielle Brittin, resident, questioned about forming an Economic Development Committee. At this time, no new committees are being formed.

There being no one else desiring the floor, the Mayor closed the meeting to the public.

Motion was made by President Randolph-Sharpe, second by Councilman Jackson that the meeting be adjourned. Voice vote was unanimous in the affirmative. Motion carried.
