Second Reading Ordinance 2018-2

CALENDAR YEAR 2018

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Council of the Borough of Lindenwold in the County of Camden finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$129,267.48 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Lindenwold, in the County of Camden, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2018 budget year, the final appropriations of the Borough of Lindenwold shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$452,436.18, and that the CY 2018 municipal budget for the Borough of Lindenwold be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mayor Roach opened the meeting to the public. There being no one desiring the floor, the Mayor closed the meeting to the public.

Motion was made by Councilman Strippoli, second by Councilman DiDomenico that Ordinance 2018-2 be adopted as read on second reading. Roll call vote was unanimous in the affirmative. Motion carried.

Second Reading Ordinance 2018-3 Addition to Chapter 224-6 Parks and Recreation Areas

AN ORDINANCE ADDING TO CHAPTER 224 SECTION 6 OF THE BOROUGH OF LINDENWOLD PARKS AND RECREATION AREAS

WHEREAS, the municipal governing body of the Borough of Lindenwold wishes to ensure the beauty of the Borough's park and recreation areas, and

WHEREAS, there currently exists a situation where there is a misuse of the area in front of the amphitheater in the park on United States Avenue that is being misused as an area for sport events involving numerous players with sport equipment, and

WHEREAS, this area is not able to sustain this type of activity.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the municipal governing body of the Borough of Lindenwold, the following is added:

Section 224-6

C. No sport activity is allowed on the grass in front of the amphitheater in the park on United States Avenue. All sporting activity is by permit only using the proper fields according to Chapter 224.

In addition, the Municipal Compliance Officer, Municipal Designee, the Chief of Police, any police officer of the Borough of Lindenwold or any taxpayer or resident of the Borough may make complaint in the Municipal Court of the Borough of Lindenwold for any violation of this section or any article, section, subsection or provision thereof. Upon conviction in such case, for each and every violation the violator shall be subject to the penalties as set forth in Chapter 1, § 1-1, of this Code. Each day that a violation is permitted to exist shall constitute a separate offense.

This ordinance shall take effect upon proper passage and publication according to law.

Mayor Roach opened the meeting to the public. There being no one desiring the floor, the Mayor closed the meeting to the public.

Motion was made by Councilman Strippoli, second by Councilman Jackson that Ordinance 2018-3 be adopted as read on second reading. Roll call vote was unanimous in the affirmative. Motion carried.

Resolution 2018:126 - Read Budget by Title

WHEREAS, N.J.S. 40A:4-8, as amended by L.2015, c. 95, § 14, 2015 provides that the budget may be read by title only at the time of the public hearing if a resolution is passed by not less than a majority of the full governing body, providing that at least one week prior to the date of hearing, a complete copy of the budget has been made available for public inspection, and has been made available to each person upon request; and

WHEREAS, these two conditions have been met;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Lindenwold that the budget shall be read by title only.

Motion was made by Councilman Strippoli, second by Councilman DiDomenico that Resolution 2018:126 be adopted as read. Voice vote was unanimous in the affirmative. Motion carried.

The Business Administrator presented the Public Hearing for the 2018 Budget as per state law. She presented a power point presentation for the residents reviewing the revenue and expenses as well as the tax collection rate for 2017. She reviewed the anticipated revenue and expenses for 2018 explaining both for the General Fund, Sewer Utility Fund, and Capital fund. Based on these projections, the tax rate increase for the Municipal Budget will be .03. She also informed the residents that there were no increases in Sewer fees for 2018. She reviewed the projects that will be completed in 2018 including sidewalks, streets, and Berlin Road Phase II. She stated that if residents have any questions, to feel free to contact her. The budget will also be posted on the Borough website as required by the State of New Jersey. Resident questioned additional repairs to sidewalks will be made. The Mayor responded that these are major sidewalk projects where none existed especially for students who walk to the Lindenwold Schools.

Mayor Roach thanked the Business Administrator for her hard work putting the budget together. The Business Administrator stated that the approval from the State was received at 3:30 today.

THEREFORE BE IT RESOLVED by the Mayor and Borough Council of the Borough of Lindenwold that Corey Rasmussen be hired as a full-time Code Enforcement Officer effective April 30, 2018 with a salary of \$38,500.

Robin Sadler, resident, questioned the cleanup at the lake.

The trees were cleared for the public access. He will let the community know about the plans for the boat ramp. Conni Spiegle, resident, complemented on the budget presentation. She questioned the opening of Laurel Road. The Police Chief provided the update that there have been delays due to the weather.

Trevor Shaw, resident, also thanked everyone for the Laurel Lake cleanup and thanked Mayor and Council for the upcoming boat ramp.

There being no one desiring the floor, the Mayor closed the meeting to the public.
