It's time for our Spring/Summer Newsletter. Please take the time to enjoy all of the enclosed useful information. I hope you find it very informative.





Lindenwold opens its first dog park at 808 West Park Ave. The free-access park, features two fenced-in areas. One pen is earmarked for smaller dogs under 30 pounds and the other is for larger dogs over 30 pounds. This fenced-in area will allow dogs to run off-leash. Dogs that are allowed to run off-leash must always be under the control of their owner. Dogs that are deemed aggressive toward other dogs or people will not be allowed at the park. The park is closed from dusk to dawn. Dogs must be properly licensed & current on all vaccinations.



The Code Enforcement Office would like to bring to your attention some of the top violations and ask that you take the time to clean up your property to avoid a violation letter or summons for noncompliance:

- 1. **High Grass and Weeds** Overgrown grass and weeds, overgrown and/or dead shrubs, dead and/or dying trees that may cause a safety hazard to the public. The grass along the curb and sidewalks are the responsibility of the property owner to maintain.
- **2. Unfiltered Pools and Ponds** Pools and ponds must be actively filtered when filled with water to prevent the spread of mosquitoes.
- 3. Pools Refer to Ordinance 365-15, 365-20 & 398-19. Please call extension 225 for more details.

 REMINDER: State Regulations requires any pool over 24" deep <u>must apply for a permit</u> as well as maintain ing proper fencing requirements. This includes inflatable pools.
- **4. Junk/Unregistered Vehicles** Any vehicle that is not legally registered, missing license plates, has flat tires, broken windows, or may be being used for storage of materials of all types.
- 5. Parking of Vehicles on Lawn the parking of any type of vehicle on lawns is prohibited.
- **6. Parking of** trailers, boats, campers and buses on streets are prohibited. No overnight parking of buses, tractor and/or trailers in driveways or parking lots.
- 7. Unlicensed Dogs and Cats All dogs and cats must be licensed. The limit is three (3) dogs and three (3) cats per household. The leash law applies to both dogs and cats. Call extension 241 for more details.
- **8. Fences** shall be maintained in good repair. "Good Repair" meaning but not limited to erect, no broken pieces, no holes, and no peeling paint. Call extension 223 if replacing or installing new fencing.
- 9. Trash and Recycling Residents must use Borough supplied trash and recycling cans on regular pick up day. REMINDER: Recycling is the law.
- 10. Re-Sale of Residential Property All sales <u>MUST</u> apply for a "CCO Inspection" (Certificate of Continued Occupancy) or a "CTT Inspection" (Certificate of Title Transfer for Vacant or Rehab Properties)
 BEFORE SETTLEMENT. Call extension 224 for details.
- **11. Housing Rental Registration** All rental properties must be registered as a rental and inspected **PRIOR** to tenant moving in. Call extension 224 for details.
- 12. House Numbers It is very important to have house numbers on all residential and commercial properties. Minimum 4" and visible from the street. For Multi-dwelling, each unit must have numbers and/or letters installed above or next to all exterior doors or patio entrances, front, back, and side. Code #92-3 B (2). Multi-dwelling/attached units must have a sign on the exterior door used for "Storage" and/or "HVAC" minimum 2". Refer to Ordinances 92-1 & 92-3 or all extension 224 for more details. Businesses need numbers and/or letters minimum 4", front, back & side. Code 92-3 B (3).
- 13. Mercantile License Any new or existing business must file for a Mercantile License. Call extension 223.
- **14. Solicitors** Must have a permit, call extension 223.
- **15. Curbs, Sidewalks, Driveway, Aprons, Walkways, Patios etc. -** Please repair and/or replace if damaged. Call extension 223 for details on type of permit needed and inspection schedule.

LINDENWOLD DEPARTMENT OF CODE ENFORCEMENT

- **16. Dumpsters/Storage Containers** A Permit is required for temporary street placement in the event that off-street parking is physically impossible. Call extension 223.
- 17. Littering #229-9B— No person shall deposit upon the surface of any public or private property or upon any street, lane or alley any rubbish or matter likely to decompose or be blown about by the wind or use any such substances to fill in or grade the surface level of any ground in the Borough.
- **18. Dumping #276-25** It shall be unlawful for anyone to discard or dump along any street or road, on or off any right-of-way, any household or commercial solid waste, rubbish, refuse, junk, vehicle or vehicle parts, rubber tires, appliances, furniture or private property.

The Code Enforcement Office would like to thank all of the residents who may have received a violation or complaint for their cooperation in promptly correcting the matter. We appreciate your efforts in helping to keep Lindenwold clean. To report a violation or to file a complaint, please contact the Code Enforcement Office at extension 244 or 254 (Spanish).

- Permits and/or Zoning Approval required but not limited to new homes, additions, above/in ground swimming pools, hot tubs, garage or basement conversions, HVAC, electrical service and/or upgrades, water/sewer connections, pole barns, car ports, sheds, decks, fences, sidewalks, walkways, patio pads, demolition and change of use. If you are not sure if a permit is required, please call 856-783-2121 Ext. 225.
- 2. <u>Please note that the "New Jersey Contractors' Registration Act"</u> requires that all "Home Improvement Contractors" be registered with the "NJ Department of Consumer Affairs". Make sure any contractor you hire is registered, licensed and insured. **Permits cannot** be issued to a "Home Improvement Contractor" who is not registered with the state of New Jersey.
- 3. **Contractors Responsibility for Material Disposal** If you are having a contractor do any work in your home/property, please remind them that it is their responsibility to remove all debris before leaving the job. This is necessary as our Borough does not become a dumping site for all contractors.
- 4. **Street Opening Permit** Permit includes but not limited to such items as installing and/or replacing curbs. Please call extension 223.





Lindenwold's Department of Assessment Services determines the market value of all real estate within the Borough for assessing purposes. The Assessor's Office will review all recorded deed transfers, update property owner mailing address changes, and assist with the Petition of Appeal process. The Assessor's Office also provides applications for and answers questions regarding the following Property Tax Deduction and Exemption programs:

- Income-qualifying homeowners who are 65 years and older, are a surviving spouse of a 65 years and older Borough homeowner, or are homeowners that are physician certified disabled, may receive a yearly \$250 deduction on their property taxes.
- Qualifying Veterans and Widows of Veterans may receive a \$250 deduction on their property taxes.
- Permanently disabled Veterans may be entitled to full exemption from property taxes.

The Assessor's Office also administers the Five-Year Residential Abatement Program. Certain qualifying improvements completed through a valid permit (i.e. additions, decks, large sheds, extra bathrooms, finished basements, etc.) which would add value to a home 20 years of age or older, may be eligible for a Property Tax Abatement. Upon approval, the assessed value which is added may be abated for 5 years.


PLEASE NOTE UPDATED QUALIFYING VETERANS' SERVICE:

Public Law 2019, Chapter 413 became operative when New Jersey voters approved a Constitutional Amendment, effective December 4, 2020, to eliminate the wartime service requirement for both the \$250 Veteran Property Tax Deduction and the Disabled Veteran Property Tax Exemption.


DOG & CAT LICENSES


The State of New Jersey mandates all dog and

cats must have current rabies vaccinations pursuant to Statute NJSA 4:19-15.2. Pet owner must license their pet yearly in January. Pets that are spayed/neutered are



\$15 or non-spayed/neutered are \$20. A late fee of \$25 will be applied after March 31. For your convenience, the application is available on the Borough website. Pursuant to NJSA 4:19-15.1, the rabies vaccination certificate must be valid thru October 31 of the current year. The Department of Health states that administering this vaccine before the expired date does not affect the animals. Guide to Prevention and cruelty laws 4:22-26 are available at the Clerk's office.

DOES YOUR FAMILY HAVE AN ESCAPE PLAN?

Plan Ahead! If a fire breaks out in your home, you may have only a few minutes to get out safely once the smoke alarm sounds. Everyone needs to know what to do and where to go if there is a fire.

SAFETY TIPS

- MAKE a home escape plan. Draw a map of your home showing all doors and windows. Discuss the plan with everyone in your home.
- KNOW at least two ways out of every room, if possible. Make sure all doors and windows leading outside open easily.
- HAVE an outside meeting place (like a tree, light pole or mailbox) a safe distance from the home or apartment where everyone should meet.
- PRACTICE your home fire drill at night and during the day with everyone in your home, twice a year.
- PRACTICE using different ways out.
- TEACH children how to escape on their own in case you can't help them.
- CLOSE doors behind you as you leave.

IF THE ALARM SOUNDS....

- If the smoke alarm sounds, GET OUT AND STAY OUT. Never go back inside for people or pets.
- If you have to escape through smoke, GET LOW AND GO under the smoke to your way out.
- If you are in need of a smoke alarm, please call the Lindenwold Fire Prevention Bureau at (856) 346-0935 and we will come out and provide a smoke alarm free of charge.



Grilling Safety Tips for Summer Barbecues

- * Only use grills outside
- *Place your grill at least 10 feet away from your home
- * Make sure your grill is located on a flat, level surface
 - * Check your grill for leaks
 - * Always clean your grill after use
- * Never leave your barbecue grill unattended while in use
 - * Keep children and pets away from your grill


flower beds to house the butterfly garden as part of her Eagle Scout Project. Love Lindenwold will assist the District by caring for the garden during the summer months when school is not in session.





GUIDELINES FOR LEAF COLLECTION

- There will be NO WEEKLY COLLECTION OF VEGETATION DURING THE MONTHS OF NOVEMBER AND DECEMBER. In the event of an emergency (extreme storm damage) please call the Public Works Department for special consideration for pickup of vegetation. Regular vegetation will resume on the first Monday in January.
- During your scheduled collection period, please have your cars off the street.
- Please have all leaves raked to curbside by the date specified in the above schedule for your Leaf Section.
 NO BAGS PLEASE! Residents who live on the following high traffic streets may bag their leaves: White
 Horse Pike, Berlin Rd, Chews Landing Rd., Blackwood-Clementon Rd., Laurel Rd., and Gibbsboro Rd.
 ONLY.
- If you should see our trucks in your district ahead of schedule, please do not be alarmed. Should our work load permit, we may send a crew out early to begin picking up whatever has already been raked to the curb, however, all streets will be started on the date specified in the above schedule.
- PLEASE BE PATIENT. Along with equipment failures and weather conditions, we may experience some delays. Our commitment is to remove the leaves from your curb as quickly as possible.
- Please do not mix any vegetation (logs and branches) in with your leaves. We will be unable to collect
 any leaves which are mixed with other material. You may however, MIX JUST GRASS CLIPPINGS
 WITH LEAVES.

olutions to Stormwater Pollution

Easy Things You Can Do Every Day To Protect Our Water

A Guide to Healthy Habits for Cleaner Water

Pollution on streets, parking lots and lawns is washed by rain into storm drains, then directly to our drinking water supplies and the ocean and lakes our children play in. Fertilizer, oil, pesticides, detergents, pet waste, grass clippings: You name it and it ends up in our water.

Stormwater pollution is one of New Jersey's greatest threats to clean and plentiful water, and that's why we're all doing something about it.

By sharing the responsibility and making small, easy changes in our daily lives, we can keep common pollutants out of stormwater. It all adds up to cleaner water, and it saves the high cost of cleaning up once it's dirty.

As part of New Jersey's initiative to keep our water clean and plentiful and to meet federal requirements, many municipalities and other public agencies including

colleges and military bases must adopt ordinances or other rules prohibiting various activities that contribute to stormwater pollution. Breaking these rules can result in fines or other penalties.



As a resident, business, or other member of the New Jersey community, it is important to know these easy things you can do every day to protect our water.

Limit your use of fertilizers and pesticides

- Do a soil test to see if you need a fertilizer.
- Do not apply fertilizers if heavy rain is predicted.
- Look into alternatives for pesticides.
- Maintain a small lawn and keep the rest of your property or yard in a natural state with trees and other native vegetation that requires little or no fertilizer.
- If you use fertilizers and pesticides, follow the instructions on the label on how to correctly apply it.



Make sure you properly store or discard any unused portions.

Properly use and dispose of hazardous products

- Hazardous products include some household or commercial cleaning products, lawn and garden care products, motor oil, antifreeze, and paints.
- Do not pour any hazardous products down a storm drain because storm drains are usually connected to local waterbodies and the water is not treated.

- If you have hazardous products in your home or workplace, make sure you store or dispose of them properly. Read the label for guidance.
- Use natural or less toxic alternatives when possible.
- Recycle used motor oil.
- Contact your municipality, county or facility management office for the locations of hazardous-waste disposal facilities.



Keep pollution out of storm drains

- Municipalities and many other public agencies are required to mark certain storm drain inlets with messages reminding people that storm drains are connected to local waterbodies.
- Do not let sewage or other wastes flow into a stormwater system.

Clean up after your pet

- Many municipalities and public agencies must enact and enforce local pet-waste rules.
- An example is requiring pet owners or their keepers to pick up and properly dispose of pet waste dropped on public or other people's property.
- Make sure you know your town's or agency's requirements and comply with them. It's the law. And remember to:
- Use newspaper, bags or pooper-scoopers to pick up wastes.
- Dispose of the wrapped pet waste in the trash or unwrapped in a toilet.
- Never discard pet waste in a storm drain.

Don't feed wildlife

- Do not feed wildlife, such as ducks and geese, in public areas.
- Many municipalities and other public agencies must enact and enforce a rule that prohibits wildlife feeding in these areas.



Dispose of yard waste properly

- Keep leaves and grass out of storm drains.
- If your municipality or agency has yard waste collection rules, follow them.
- Use leaves and grass clippings as a resource for compost.
- Use a mulching mower that recycles grass clippings into the lawn.

Don't litter

- Place litter in trash receptacles.
- Recycle. Recycle. Recycle.
- Participate in community cleanups.
