Police Department Earns Accreditation

The Lindenwold Police Department has achieved Accreditation from the [New Jersey State Association of Chiefs of Police](#) (NJSACOP). The foundation of Accreditation lies in the adoption of standards containing a clear statement of professional objectives. Participating agencies conduct a thorough self-analysis to determine how existing operations can be adapted to meet these standards and objectives. When the procedures are in place, a team of trained, independent assessors verifies that the applicable standards have been successfully implemented. This Accreditation certification will last 3 years, at which time we will again go through the re-accreditation process.



Chief McCarthy Graduation from FBI National Academy



On September 14, 2023, Chief Michael McCarthy Jr. graduated as a member of the 287th session of the FBI National Academy. The graduation took place at the National Academy in Quantico, Virginia. Chief McCarthy is the third officer in department history to complete this prestigious program. Nationally, fewer than one percent of officers have the opportunity to attend the program.

Internationally known for its academic excellence, the National Academy offers ten weeks of advanced communication, leadership, and fitness training. Participants must have proven records as professionals within their agencies to attend. On average, these officers have 21 years of law enforcement experience and usually return to their agencies to serve in executive-level positions.

Deputy Chief Cavallaro Retirement

Please join us in congratulating Deputy Chief Michael Cavallaro on his retirement after 25 years of service. Inspired by his father who was a Trooper, D/C Cavallaro joined the ranks of the department in January of 1997. He remained in the patrol division until May of 2003 when he was assigned to the Detective Bureau. In March of 2007, he was promoted to Sergeant in the patrol division. In July of 2013, he was promoted to Lieutenant and assigned to the Detective Bureau and Internal Affairs. In February of 2020, he was promoted to Captain. In that role, he supervised all day to day operations of the Department and was the primary Training Officer. In March of 2022, he was promoted to the rank of Deputy Chief and assigned as the Department's first accreditation manager. D/C Cavallaro successfully navigated the Department through the accreditation process and we received accreditation status in June of 2023. We thank him for his dedicated service and wish him a long and healthy retirement.

Free Smoke Alarm Inspection & Installation

One of the most important fire safety devices for the home is a smoke alarm. It is estimated that a third of smoke alarms are not working, often due to the failure to replace a worn out battery. If you need a smoke alarm or are not sure that yours are in proper working order, please call to schedule an appointment. If it needs to be replaced the Fire Department will install a 10-year long life battery powered smoke alarm free of charge.

Prescription Drop Off Box (MedReturn)

Do your part to fight the opioid epidemic by disposing your unused or expired prescription medication in the MedReturn drop box.

In an effort to stop the abuse and diversion of prescription drugs, Lindenwold residents are encouraged to dispose of their unused medications safely and securely. The medications will then safely & properly be destroyed.

The drop off boxes accepts solid pharmaceuticals such as pills, capsules, patches, and pet medications. They cannot accept inhalers, syringes or liquids.



Did you update your driver's license to your new Lindenwold address?

New Jersey requires you to notify your state's Department of Motor Vehicles about your change of address within a set time period (some states allow up to 30 days but others impose deadlines of 10 days – or less). Generally, though, you won't need to get a new license. In most states, it will be enough to submit a change of address online and print for your records. This updates your address in the DMV database even though your license will still have your old address. DMV no longer issues a sticker.

DOG & CAT LICENSES

The State of New Jersey mandates all dogs and cats must have current rabies vaccinations pursuant to Statute NJSA 4: 19-15.2. Every pet owner must license

their pet yearly in January. Pets that are spayed/neutered are \$15.00 or non-spayed/neutered are \$20. A late fee of \$25 will be applied after March 31. For your convenience, the application is available on the Borough website.

Pursuant to NJSA 4: 19-15.1, the rabies vaccination certificate must be valid thru October 31 of the current year. The Department of Health states that administering this vaccine before the expired date does not adversely affect the animals. Guide to Prevention and Cruelty laws 4:22-26 are available at the Clerk's Office.

Winter Holiday Safety



Winter holidays are a time for families and friends to get together. But that also means a greater risk for fire. Following a few simple tips will ensure a happy and fire-safe holiday season.

- Be careful with holiday decorations. Choose decorations that are flame resistant or flame retardant.
- Keep lit candles away from decorations and other things that can burn.
- Keep children and pets away from lit candles.
- Stay in the kitchen when cooking on the stovetop.

Some simple steps can prevent most heating-related fires from happening:

- Keep anything that can burn at least three feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Have a three-foot “kid-free zone” around open fires and space heaters.
- Never use your oven to heat your home.

Chiminea and Outdoor Fireplace Safety

The use of Chimineas and outdoor fireplaces is becoming increasingly popular in backyards throughout Lindenwold. The use of chimineas are allowed under the state fire code, however; there are restrictions that residents need to be aware of. Keeping to the requirements and safety tips will ensure a safe and enjoyable outdoor experience.

General Safety Practices:

Locate the fireplace at least fifteen (15) feet away from your house. Maintain a minimum distance of three (3) feet from any combustible material or item.

Do not use during a high wind condition.

The fireplace should be located on a non-combustible surface such as a brick or concrete patio.

Never use a flammable liquid to start the fire.

Prior to removing ashes, allow them to cool for at least twenty four (24) hours. Keep the ashes in a metal waste can with a tight fitting metal lid and keep it **AWAY FROM THE HOUSE.**

It is very important to have house numbers. A minimum of 4" and visible from the street to avoid violation. Code S92-1

Each unit in the multi-family dwelling must have numbers or letters installed above or next to all exterior doors or patio entrances, front, back, and side. Code 92-3 B (2)

Businesses need numbers or letters a minimum of 4" on front and back doors. Code 92-3 B (3)

Winter is on its way. Please repair and/or replace damaged sidewalks, driveways and aprons. Code S190-73. Zoning permit or street opening permit required. Call 856-783-2121 ext. 223

All sidewalks must be clear of ice and snow within 12 hours of daylight after the storm. Code S296-33

To report a violation call 856-783-2121 ext. 248 or ext. 224 for Spanish

CONSTRUCTION: Permits are required but not limited to new homes, additions, above/in ground pools, hot tubs, garage or basement, new or replaced HVAC, electrical service upgrades, water/sewer connections, pole barns, sheds, decks, demolition and change of use. For more information call 856-783-2121 ext. 225

Please note that the New Jersey Contractors' Registration Act requires that all Home Improvement Contractors be registered with the NJ Department of Consumer Affairs. Make sure any contractor you hire is registered, licensed, and insured. Permits cannot be issued to a Home Improvement Contractor who is not registered with the State of New Jersey.

It is the contractor's responsibility for the removal/disposal of all debris.

MERCANTILE LICENSE: Any new, existing, or change in ownership of business must file for a mercantile license. call 856-783-2121 ext. 223

HOUSING: All rental properties must be registered and inspected before a tenant takes occupancy. Call 856-783-2121 ext. 224.

All sales of residential properties must apply for CCO/CTT inspection. Call 856-783-2121 ext. 224

SOLICITORS: Must apply for a license. Solicitors are only permitted to solicit between 10:00 am - 6:00 pm. If a solicitor comes to your door, always ask to see the license issued from Lindenwold. If they do not provide it, call the police. Should you have any questions, call 856-783-2121 ext. 223

The Lindenwold Board of Education, at its September 25, 2023 board meeting, awarded the construction of the new Early Childhood Center(ECC) to Dinallo Construction Corporation. The new ECC project planning began back in March 2020 and has taken many hours of design and preparation to get to this point. The construction award is within the budget that was presented to voters at the bond referendum in January 2022 and the project has had zero impact on the school tax levy. We are very excited to begin building this modern-day facility to house our preschool, kindergarten and first grade students. In addition, this project will allow us to move our fifth-grade students from the middle school into the elementary schools, thus creating much needed space at the middle school location. The building is anticipated to be ready for our staff and students in September 2025!

In addition, the District was recently awarded \$28,811,823 as part of the State of NJ School Construction Funding Awards. The NJ School Development Authority awarded \$450 million to 261 districts across the state and Lindenwold received the largest award in the state. We will use these funds to complete Heating, Ventilation and Air Conditioning (HVAC) improvements at all buildings as well as replace the majority of the roofs at all school building locations.

The official unveiling of the mural took place on October 19, 2023 during our Hispanic Heritage Night which will run from 6pm – 8pm at Lindenwold High School. Ms. Salabie was present to share her work with the community throughout that evening.

Ms. Salabie was also recently featured on Fox 29 for being an author/illustrator of children’s literature. She shared her published books with the students of her alma mater – School 5 Elementary School in Lindenwold New Jersey.

THE STORY OF THE MURAL – THE AMERICAN DREAM

For many of our students and their families, Lindenwold is a place of opportunity. It is for many, the 21st century American Dream. Our students believe through hard work and education, that anything is possible. One of these students, Shiane Salabie, the mural’s artist (Class of 2014) immigrated to the US with her parents from Jamaica at 4 years old. She walked these halls as a student, not knowing she would one day use her artistic gifts to tell not only her story, but the story of so many.

“The American Dream” mural is a graphic storyline of 3 major time periods of American migration. It begins with the early 19th Century European wave of immigration with imagery of The New York skyline, The Statue of Liberty, and families arriving on the docks chasing “The American Dream.” The Middle cluster focuses on The Great Migration as Black families broke free from the oppressive agricultural lifestyle of the “Jim Crow” South. Families packed their cars, loaded onto trains, and chased “The American Dream” into the Northern industrial factories. The final cluster depicts our more recent Latinx immigration movement with colorful cultural imagery, leading to 3 current LHS students and our Lion now living, “The American Dream” - Paul Maggi

Lindenwold Public School District Community Partnerships

Mrs. Amber Callow is entering her second year as Lindenwold Public Schools' Community & Inclusion Coordinator. In her second year, she is looking to build upon the success of the previous school year, while continuing to broaden the district and community's partnerships. The first large-scale district/family engagement event is Hispanic Heritage Night scheduled for Thursday, October 19th at Lindenwold High School. The event will feature community outreach tables hosted by the Lindenwold Police Department and Lindenwold Fire Department, authentic food from local staples La Esperanza and El Salvadoreno, and live music from Nivel Alto, which is fronted by LHS 2020 graduate Bryan

Towards the end of 2023, the District plans to partner with the Borough and other community organizations to offer Holiday food and assistance to Lindenwold Families. Last Holiday Season, Project E.L.F. and "Shop with a Cop" provided holiday gifts to over 200 Lindenwold students.

In February, the District plans to hold its second large-scale family engagement event for Black History Month, following in the footsteps of our first ever Juneteenth Celebration at the end of the 2023 school year.

In March, we will again open our doors to Board of Education members, council members, Borough employees, and parents for Read Across America Week, while inviting school staff to "Bring Their Child to Work" in April.

The District will round out the school - year by celebrating our College, Military, Trade-School and Career-bound Seniors, and by hosting a third large-scale district/family engagement event in the late Spring.

The District is committed to growing our community partnerships with our family year by year.



The Lindenwold School District would like to give a huge Shout Out to High School Physics and Computer Science teacher Mr. Bryan Callow. Mr. Callow was chosen to be an Amazon Future Engineer Teacher Ambassador this past year. Mr. Callow is the only ambassador to be selected from New Jersey. To be considered for this program, Mr. Callow went through an extensive application process which included information about himself and the district, short answer questions, and a 3-5-minute video.

According to Amazon, "The Amazon Future Engineer Teacher Ambassador Program exists as a paid professional development experience designed to increase access to computer science and technology for all students and teachers. Approximately, 50 educators from across the United States representing a diverse range of grades, regions, and communities will be selected for a two-year long commitment." Mr. Callow started his Teacher Ambassador journey this summer with meetings in Seattle, Washington, and he will continue his professional Development with virtual meetings every month. Mr. Callow stated that, "I am very grateful and humbled to be a part of this, and I look forward to driving the growth of computer science education in Lindenwold."

Congratulations to Mr. Callow for being selected to this program, and thank you for sharing all your knowledge with the students and staff of the Lindenwold School District.



When a winter storm hits our area, property owners can assist the Borough by adhering to the following suggestions:

1. The Borough's initial priority is to clear an access to the primary roads with additional passes to push snow to the edge of the street.
2. Try to avoid parking vehicles in the street if possible.
3. **BE AWARE THAT WHEN STREETS ARE PLOWED, THE SNOW IS GOING TO GET INTO YOUR DRIVEWAY.** If possible, wait until the street is completely cleared before attempting to clear any driveway openings.
4. Do **NOT** shovel snow into the street. This can lead to hazards with freezing temperatures. Try to shovel away from the street.
5. As a safety precaution, please shovel out fire hydrants.
6. The Borough does not shovel sidewalks and cannot clear driveways. They are working around the clock to provide the best service to the residents.
7. County roads are maintained by the Camden County Public Works. If you have questions regarding a county road, please call 856-566-2980.
8. We will do our best to keep trash route schedules the same. For information regarding any changes to our schedules, please visit the Borough website or our Facebook Page "Lindenwold Public Works."

We understand that winter weather can be frustrating and we are empathetic to each resident's particular needs and concerns, so we will do our best to restore the roadways to normal conditions as soon as possible.

CART PLACEMENT

Place carts at least 10 feet away from any car and 3 feet from any other items like other carts, fences, utility poles, mailboxes or any other items that may prevent the automated truck from emptying it.

Only Borough issued carts will be collected.

Carts must be set out on your collection day before 6:30 a.m. The Carts must be set with the wheels and handle facing your home and the arrow on lid pointing to the roadway. Lids must remain closed for collection.

GUIDELINES FOR LEAF COLLECTION

- There will be **NO WEEKLY COLLECTION OF VEGETATION DURING THE MONTHS OF NOVEMBER AND DECEMBER.** In the event of an emergency (extreme storm damage) please call the Public Works Department for special consideration for pickup of vegetation. Regular vegetation will resume on the first Monday in January.
- ***During your scheduled collection period, please have your cars off the street.***
- Please have all leaves raked to curbside by the date specified in the above schedule for your Leaf Section. **NO BAGS PLEASE!** Residents who live on the following high traffic streets may bag their leaves: White Horse Pike, Berlin Rd, Chews Landing Rd., Blackwood-Clementon Rd., Laurel Rd., and Gibbsboro Rd. **ONLY.**
- If you should see our trucks in your district ahead of schedule, please do not be alarmed. Should our work load permit, we may send a crew out early to begin picking up whatever has already been raked to the curb, however, all streets will be started on the date specified in the above schedule.
- **PLEASE BE PATIENT.** Along with equipment failures and weather conditions, we may experience some delays. Our commitment is to remove the leaves from your curb as quickly as possible.
- Please do not mix any vegetation (logs and branches) in with your leaves. We will be unable to collect any leaves which are mixed with other material. You may however, **MIX JUST GRASS CLIPPINGS WITH LEAVES.**
- ***There will be a Spring Collection of leaves during the first week of May. Leaves must be raked to curbside loosely. NO BAGS PLEASE.***

Winter Termination Program

If you are having trouble paying your residential electric, sewer and water service bills this winter, the NJ Department of Community Affairs has a program to protect you from having these utilities turned off from

November 15 through March 15

Who is Eligible?

You qualify for protection during this period if you are being helped by one of the programs listed below:

- Federal Home Energy Assistance Program (HEAP)
- Temporary Assistance to Needy Families (TANF)
- Federal Supplemental Security Income (SSI)
- Pharmaceutical Assistance to the Aged and Disabled (PAAD)
- General Assistance (GA) benefits
- Universal Service Fund (USF)
- Low-income Household Water Assistance Program
- Lifeline Credit Program

OR

You are unable to pay your utility bills because of circumstances beyond your control such as unemployment, illness, medically related expenses, recent death of an immediate family member, and any other circumstances, which might cause financial hardship.

What do you have to do?

1. If you qualify for protection from shut-off during this period, you should contact your utility company to advise the company that you are eligible for coverage under the State's Winter Termination Program. You should also pay as much as you can on your bill(s) during the winter.
2. Customers also have the option to complete the following Self-Certification form and provide this form to their utility company as a way of notifying the company of their eligibility for protection. When using the Self-Certification form it is recommended that a copy of the form be retained for one's personal records. [Click here for the Self-Certification Form](#)

Please note that completion and submission of the Self-Certification form to your utility company is NOT required in order to receive protection under the Winter Termination Program. Protection under the Winter Termination Program can be obtained by verbally advising your utility company(ies) of your eligibility or by submitting this Self-Certification form to the utility company. In either case, please contact your utility company's customer service number to report your eligibility and/or learn how it wishes to receive the Self-Certification form.
