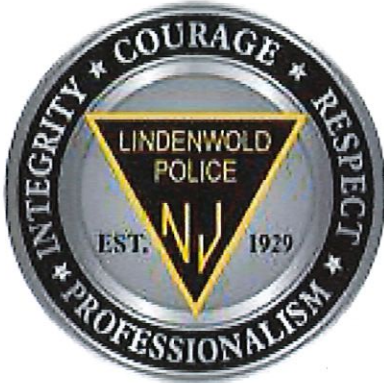

### **Lindenwold Police Department Partners with Volunteers of America Delaware Valley (VOA-DV) to provide Social Services to the Community**

The Lindenwold Police Department has entered into an affiliation agreement with Volunteers of America (VOADV) Delaware Valley to provide social services to Lindenwold residents struggling with homelessness, addiction, domestic violence, mental health, and poverty- all of which are key drivers of crime. The VOA has trained social workers on staff who work side by side with local police officers to provide direct services to residents in need. The program, originally piloted in Pine Hill, provides direct services to the community, creating easier access to services for at-risk populations. The program is known as IMPACT (Immediate Mobilization of Police Assisted Crisis Teams) Initiative designed to meet individuals where they are and offer immediate and direct linkages to social services.

This partnership is a key part of the Lindenwold Police Department's community policing approach to reducing crime and disorder within our community. The IMPACT program receives funding from the State of New Jersey.

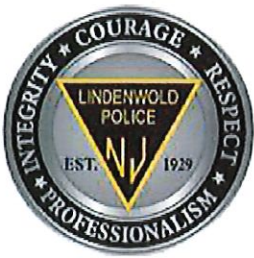
### **Lindenwold Police Department receives grant funding for Body-Worn Camera (BWC) Program**

The Lindenwold Police Department received an \$85,596.00 grant to purchase Body Worn Cameras. In November 2020, Governor Murphy signed a law mandating that every NJ uniformed patrol officer be equipped with a BWC. In December 2020, the Governor also signed a law appropriating \$58 million for grants to support the purchase of cameras and digital storage.

As of June 1, 2021, all NJ patrol officers are required to have a BWC while on duty. The Lindenwold Police Department has been using BWC since June 2019. Every Lindenwold Police Officer has been issued a BWC. The grant funds received from the NJ Attorney General's Office will fund our BWC program for the next several years. BWC serve to strengthen trust between officers and the community by ensuring accountability and transparency in policing.







# Officer Trading Card Contest July through December 2021



The Lindenwold Police Department Officer Trading Card Contest is underway and will continue through December 2021. There is still plenty of time to participate in this program. Two prizes have already been awarded! See below for more details regarding the program.

Each month, residents under the age of 18 should collect trading cards from officers when appropriate. Officers and the young resident should exchange some unknown fact (hobbies, favorite sports teams, etc.) about each other. Residents should feel free to come to the police station during business hours to obtain trading cards as well!

**For safety reasons, please don't approach an officer while they are conducting an investigation.**

During the first week of the following month, the young resident and a parent or guardian, should come to police headquarters to have the collected cards counted. (Arrangements can be made for an officer to meet the family at their residence if requested.)

The resident who obtains the most trading cards in a given month will receive an award provided by one of our community sponsors.

In the event of a tie, the winner's name will be selected through a random drawing.

A resident may only win one time during the program. Trading Cards are numbered and cannot be shared among family or friends.

The program will run through December. All participants who collect a full set of trading cards will have their names placed into a drawing to win the grand prize!

### GUIDELINES FOR LEAF COLLECTION

- There will be **NO WEEKLY COLLECTION OF VEGETATION DURING THE MONTHS OF NOVEMBER AND DECEMBER.** In the event of an emergency (extreme storm damage) please call the Public Works Department for special consideration for pickup of vegetation. Regular vegetation will resume on the first Monday in January.
- **During your scheduled collection period, please have your cars off the street.**
- Please have all leaves raked to curbside by the date specified in the above schedule for your Leaf Section. **NO BAGS PLEASE!** Residents who live on the following high traffic streets may bag their leaves: White Horse Pike, Berlin Rd, Chews Landing Rd., Blackwood-Clementon Rd., Laurel Rd., and Gibbsboro Rd. **ONLY.**
- If you should see our trucks in your district ahead of schedule, please do not be alarmed. Should our work load permit, we may send a crew out early to begin picking up whatever has already been raked to the curb, however, all streets will be started on the date specified in the above schedule.
- **PLEASE BE PATIENT.** Along with equipment failures and weather conditions, we may experience some delays. Our commitment is to remove the leaves from your curb as quickly as possible.
- Please do not mix any vegetation (logs and branches) in with your leaves. We will be unable to collect any leaves which are mixed with other material. You may however, **MIX JUST GRASS CLIPPINGS WITH LEAVES.**
- **There will be a Spring Collection of leaves during the first week of May. Leaves must be raked to curbside loosely. NO BAGS PLEASE.**

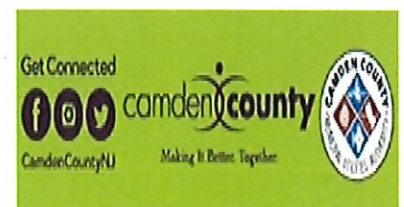

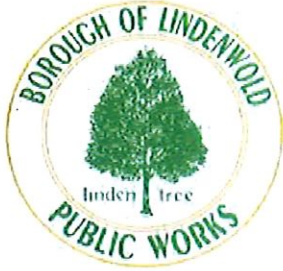

When a winter storm hits our area, property owners can assist the Borough by adhering to the following suggestions:



1. The Borough's initial priority is to clear an access to the primary roads with additional passes to push snow to the edge of the street.
2. Try to avoid parking vehicles in the street if possible.
3. **BE AWARE THAT WHEN STREETS ARE PLOWED, THE SNOW IS GOING TO GET INTO YOUR DRIVEWAY.** If possible, wait until the street is completely cleared before attempting to clear any driveway openings.
4. Do NOT shovel snow into the street. This can lead to hazards with freezing temperatures. Try to shovel away from the street.
5. As a safety precaution, please shovel out fire hydrants.
6. The Borough does not shovel sidewalks and cannot clear driveways. They are working around the clock to provide the best service to the residents.
7. County roads are maintained by the Camden County Public Works. If you have questions regarding a county road, please call 856-566-2980.
8. We will do our best to keep trash route schedules the same. For information regarding any changes to our schedules, please visit our

It is very important to have house numbers. A minimum of 4" and visible from the street to avoid violation Code S92-1.

Each unit in the multi-family dwelling must have numbers or letters installed above or next to all exterior doors or patio entrances, front back or side. Code 92-3 B (2).

Businesses need numbers or letters a minimum of 4" on front and back doors. Code 92-3 B (3).

Winter is on its way. Please repair and/or replace damaged sidewalks, driveways and aprons. Code S190-73. Zoning permit or street opening permit required. Call 856-783-2121 ext. 223.

All sidewalks must be clear of ice and snow within 12 hours of daylight after the storm. Code S296-33

To report a violation, call 856-783-2121 ext. 248 or ext. 254 for Spanish.

**CONSTRUCTION** – permits are required but not limited to new homes, additions, above/in ground pools, hot tubs, garage or basement conversions, new or replaced HVAC, electrical service upgrades, water/sewer connections, pole barns, sheds, decks, demolition and change of use. For more information call 856-783-2121 ext. 225.

Please note that the New Jersey Contractors' Registration Act requires that all Home Improvement Contractors be registered with the NJ Department of Consumer Affairs. Make sure any contractor your hire is registered, licensed and insured. Permits cannot be issued to a Home Improvement Contractor who is not registered with the State of New Jersey.

It is the contractor's responsibility for the removal/disposal of all debris.

**MERCANTILE LICENSE** – Any new or existing business must file for a mercantile license. Call 856-783-2121 ext. 223.

**HOUSING** – All rental properties must be registered and inspected before a tenant takes occupancy. Call 856-783-2121 ext. 224.

All sales of residential properties must apply for CCO/CTT inspection. Call 856-783-2121 ext. 224.

**SOLICITORS** – Must apply for a license. Solicitors are only permitted to solicit between 10:00 am – 6:00 pm. If a solicitor comes to your door, always ask to see the license issued from Lindenwold. If they do not provide it, call the police. Should you have any questions please call 856-783-2121 ext. 223.

**DUMPSTERS** – Permit needed for Street placement, Code 220-14 call 856-783-2121 ext. 223.





## **S100-1 Burning of Rubbish Prohibited – Open burning and recreational fires**

- A. It shall be unlawful at any time for any person or persons or corporation to burn brush, weeds, grass, leaves, wastepaper or other hazardous materials.  
No open fire or outdoor fire shall be conducted on any porch, deck, balcony or other portion of a building; within any room or space within a building; or under any building overhang; provided, however, that an open fire or outdoor fire may be conducted on a concrete or stone patio if and only if all other provisions of this article are met.
- B. Fires shall be limited to a maximum four-foot diameter and two feet in height and must be contained in a noncombustible chimenea, outdoor fireplace, fire pit, or other method approved by the Fire Marshall.
- C. All openings in the container or fire pits must be covered with wire mesh or other screening materials that will prevent the passage of sparks and embers.
- D. The location for open burning shall not be less than 50 feet (15 240 mm) from any structure, and provisions shall be made to prevent the fire from spreading to within 50 feet (15 240 mm) of any structure.

EXCEPTIONS: Fires in approved containers must be kept at least 15 feet from any property line, combustible exterior wall, or other combustibles that may ignite and permit the spread of fire.

Example: shrubs, trees, fences, house, sheds etc.

The minimum required distance from a structure shall be 25 feet (7620 mm) where the pile size is 3 feet (914 mm) or less in diameter and 2 feet (610 mm) or less in height.

- E. Fires must be constantly attended until completely extinguished.
- F. The Fire Marshall, Police Officer, or any Borough Official may order an outdoor burning activity to cease if conditions are such or the activity is so situated as to endanger the health or safety of persons or property located in the general area of the activity. If the party responsible for outdoor burning activity does not immediately comply with an order to cease given pursuant to this subsection, the party responsible shall be subject to the penalties set forth below. Any open fire or use of a chimenea, outdoor fireplace, or fire pit which creates a nuisance or is deemed to be a hazard is to be extinguished.
- G. Outdoor burning is not permitted when the wind exceeds 10 miles per hour.
- H. While outdoor burning is being conducted, it shall be attended by a person of at least 18 years of age at all times
- I. Adequate fire-suppression equipment such as shovels, fire extinguishers rated at 4A or larger, water hoses, or like equipment sufficient to extinguish the fire shall be present on the property at all times burning is conducted.
- J. No person shall cause an open fire or outdoor fire to be used or maintained in such a manner as to cause a nuisance to neighbors.
- K. Fire pits are NOT permitted for multi-family properties, single family only.

## **Violations and Penalties**

Any person in violation of the provisions of this article shall be subject to a penalty as follows:

- A. First offense; a verbal warning.
- B. Second offense; a written notice of violations.
- C. Third and subsequent offense: a fine not to exceed \$2,000, imprisonment for not more than 90 days and/or a period of community service not to exceed 90 days. Each day on which a violation occurs shall be considered a separate offense.

### Spotted Lanternfly

#### What to do:

If you see egg masses, scrape them off, double bag and throw away. You can also place the eggs into alcohol, bleach or hand sanitizer to kill them.

#### Collect a specimen:

Specimens of any life stage can be turned in to the New Jersey Department of Agriculture's lab for verification.

#### Take a picture:

With your GPS function turned on your smartphone or a camera with GPS, take a photograph of ANY life stage (including egg masses)

#### Report a site:

If you can't take a specimen or photograph, call and leave detailing your sighting and contact information.

**A message from the District Superintendent:**

## Update from the Lindenwold School District Business Office:

One of the biggest challenges right now is our current overcrowding problem throughout our school district. As a result, you may have noticed our new large, blue addition on the front yard of the middle school. This building is known as a TCU (Temporary Classroom Unit) and has provided our school with additional classroom units for our Lindenwold Middle School population. Currently, sixth grade students and staff have made the TCU their new home.

Although these TCUs have provided some relief to the significant overcrowding issues at the Middle School, it does not solve the District overall problem. In order to address this problem with a permanent solution, the District has submitted a new building project application to the New Jersey Department of Education to build an Early Childhood Building. This building would not only address our overcrowding needs, it will also allow us to move our 5<sup>th</sup> grade classes back into the elementary schools. In addition, it will allow us to expand programming for students who have been negatively impacted by the lack of space. If the building does become a reality, our District configuration would reflect the following:

Early Elementary Building: PK – Grade 1

School 4 / School 5: Grade 2 – Grade 5

Lindenwold Middle School: Grade 6 – Grade 8

Lindenwold High School: Grade 9 – Grade 12

Once the District receives all of the necessary approvals from the NJDOE, the plan is to allow the voters to weigh in on this project through a referendum vote. Information about the Early Childhood Building can be found on our District website. Stay tuned for community meetings scheduled for this fall 2021.

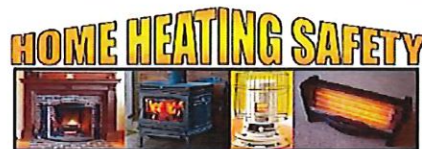

**FACT:** Heating equipment is a leading cause of home fire deaths. Half of home heating equipment fires are reported during the months of December, January, and February.

### Some simple steps can prevent most heating-related fires from happening:

- ❖ Keep anything that can burn at least three feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- ❖ Have a three-foot “kid-free zone” around open fires and space heaters.
- ❖ Never use your oven to heat your home.
- ❖ Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer’s instructions.
- ❖ Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- ❖ Remember to turn portable heaters off when leaving the room or going to bed.
- ❖ Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- ❖ Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.

According to the American Cancer Society (ACS), breast cancer is the most common cancer in American women, except for skin cancers. The average risk of a woman in the U.S. developing breast cancer sometime in her life is about 13%, or a 1 in 8 chance. This also means there is a 7 in 8 chance she will never have the disease.

The American Cancer Society's estimates for breast cancer in the United States for 2021 are:

- About 281,550 new cases of invasive breast cancer will be diagnosed in women.
- About 49,290 new cases of ductal carcinoma in situ (DCIS) will be diagnosed.
- About 43,600 women will die from breast cancer.

### Recommendation for the Early Detection of Breast Cancer

- Finding breast cancer early and getting state-of-the-art cancer treatment are the most important strategies to prevent deaths from breast cancer. Breast cancer that's found early, when it's small and has not spread, is easier to treat successfully. Getting regular screening tests is the most reliable way to find breast cancer early. The American Cancer Society has screening guidelines for women at average risk of breast cancer, and for those at high risk for breast cancer.

#### At Average Risk

- Women between 40 and 44 have the option to start screening with a mammogram every year.
- Women 45 to 54 should get mammograms every year.
- Women 55 and older can switch to a mammogram every other year, or they can choose to continue yearly mammograms. Screening should continue as long as a woman is in good health and is expected to live at least 10 more years.

#### At High Risk

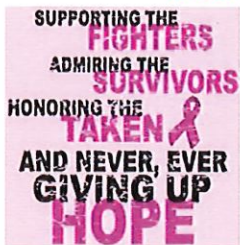
- Women who are at **high risk** for breast cancer based on certain factors should get a [breast MRI](#) and a mammogram every year, typically starting at age 30.

### Breast Cancer in Men

Breast cancer occurs mainly in women, but men can get it, too. Many people do not realize that men have breast tissue and that they can develop breast cancer. Cells in nearly any part of the body can become cancer and can spread to other areas.

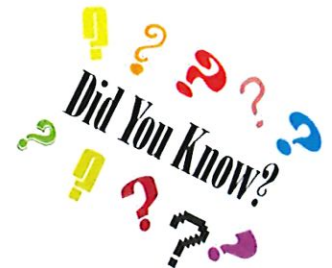
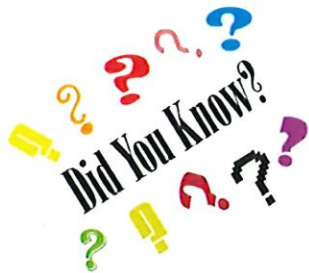

**Early In-Person Voting** is coming to New Jersey. Earlier this year, a law was passed permitting in-person early voting in New Jersey. The voting option will allow you if registered in Camden County to vote anywhere in Camden County at designated voting places 7 days a week!

### What to know:

- 1) This new option enables all registered (Camden County) voters to cast their **ballot in person, using voting machines, during a nine-day period Prior to Election Day**. You can now choose to vote, in person, when it is most convenient for your schedule.
- 2) No matter where you live in the county, you can vote your ballot at ANY of the county's designated in-person early voting locations listed below.
- 3) When can I access Early In-Person Voting: **Saturday, October 23<sup>rd</sup> through October 31<sup>st</sup>, 2021. Hours: Monday-Saturday, 10:00AM- 8:00PM and Sunday, 10:00 AM through 6:00 PM. No appointment is necessary.**

### What if I Always Vote by Mail?

Check whether or not you are active vote-by-mail voter [Vote.NJ.Gov](http://Vote.NJ.Gov) under "Am I Registered."

You may still vote in person on Election Day, Nov. 2<sup>nd</sup> from 6:00AM through 8:00PM at your regular polling place, if you choose to.

You can still vote by mail, if you wish.
